WHAT IS THE NO COMPROMISE WEEKEND?

The No Compromise Weekend is similar to the Weekend of Champions. The biggest difference is opening the registration to youth groups along with FCA Huddles. As the students register they will be assigned to a huddle led by college student. Each all-girl/all-boy huddle will function as a team throughout the weekend.

Huddle Coaches, Youth Leaders and all adults are welcome and strongly encouraged to be a part of the weekend. Special adult sessions will be held throughout the weekend.

SCHEDULE

You can download the schedule at www.nocompromiseweekend.org. The schedule is similar to the fall Weekend of Champions with the addition of a concert Saturday night. Check-in begins Saturday morning at 7:45 AM with Check-out Sunday morning at 11:30 AM.

COST

\$35 per attendee. Huddle Coaches, youth pastors and other adults are welcome to attend. Because of the extra expenses for the No Compromise Weekend, we are asking adults to pay registration along with the students. Contact your local FCA office for need based scholarships.

HOUSING

The boys and girls will be split into separate gyms for the evening with college-aged counselors supervising along with adults. Attending adults are welcome to sleep in the gyms/hallways (bring sleeping bag, cot, air mattress, etc). Adults that would prefer not to sleep at the school can make arrangements with nearby Timberlake Ranch Camp at (308) 946-3871 or Covenant Cedars (402) 757-3241 for adult housing at a reasonable rate. Super 8 Motel is also about a block from the school (308) 946-5055.

REGISTRATION

Let us emphasize the need to **REGISTER - WHICH INCLUDES PAYING THE FEES**. No refunds will be given but substitutions will be accepted. **REGISTRATIONS need to be submitted by March 15** (this helps us plan accordingly for food and huddle numbers).

Participants must check in on time and stay for the entire weekend program. Participants should bring their completed waiver to the Weekend. Please make copies of the enclosed form.

In consideration of participating in the No Compromise Weekend I represent that I understand the nature of this Activity and that I am qualified, in good health, and in proper physical condition to participate in such Activity. I acknowledge that if I believe event conditions are unsafe, I will immediately discontinue participation in the Activity.
